Fee Reduction

The School offers discount on short courses / Certificate and Diploma programmes* to the following categories of applicants:

- Senior Citizen Card holders: 50% off
- HKBU Foundation members: 20% off
- HKBU full-time staff: 20% off
- HKBU alumni at Higher Diploma/Associate Degree level or above who are HKBU Hang Seng Credit Card holders: 20% off
- HKBU Hang Seng Credit Card holders: 20% off (Applicable to Short Courses for which only Certificate of Attendance will be issued)
- SCE Friends members: 20% off short courses (Not applicable to Certificate/Diploma Programme courses, Continuing Education Fund reimbursable courses or Specified courses)
 - * The discount may not be applicable to some programmes. Please check with the Programme Teams concerned.

Continuing Education Fund (CEF)

Students enrolled in and paid the tuition fee for a CEF reimbursable course may apply for opening an account with the Office of Continuing Education Fund (OCEF) before the course commences (no re-application is required if an account has been opened). Eligible applicants will be reimbursed 80% of their fees, subject to a maximum sum of HK\$10,000 (whichever is the less), on successful completion of the reimbursable course(s) within the four-year validity period.

Students who are studying language courses are additionally required to pass or attain the minimum benchmark of specified benchmark tests within the four-year validity period.

Attention: The enhancement measures of the CEF will be implemented on 1 April 2019. All CEF reimbursable courses commence on or after 1 April 2019 will be covered. Adjustment to the application procedures, subsidy ceiling and co-payment ratios, reimbursement claims limitations, etc. will be made under the enhancement measures. Students should take note of and refer to announcements made by the OCEF.

Extended Non-means-tested Loan Scheme (ENLS)

The ENLS is administered by the Student Finance Office (SFO) of the Government and the maximum financial assistance is equivalent to the total tuition fees payable to institutions in an academic year. 修讀語文課程的申請人,另需於四年期限屆滿前取得指定語文課程基準試的合格成績或達到所需的最低基準成績。
