The SCE Research Management Committee (RMC) is pleased to announce the results of the Seed Grant Funding (SGF) Scheme - Pilot Project Grant in Environment and Human Health 2021. The Grant was launched by the Research Centre for Environment and Human Health^{*} to facilitate SCE teaching staff members to carry out preliminary/ exploratory research and investigation to prepare for external grant application in relevant fields. The applications have been reviewed by the Proposal Vetting Panels (PVP) and the Grant Vetting Sub-Committee (GVSC), and the results have been approved by the RMC.
