Subject: Call for applications of Dean's Award (Research Excellence) 2021/22

In line with the SCE strategic direction of "Building up research capacity" which was to encourage academic/ teaching staff to actively engage in research-related activities, the Dean's Award (Research Excellence) was established in AY 2020/21 to recognise research performance/ engagement of SCE academic/ teaching staff, on both an individual and a group basis.

The Dean's Award (Research Excellence) 2021/22 is now open for application. Details are as follows -

a) Eligibility

To be eligible for receiving the award, regardless of the application category the teaching staff must be full-time SCE teaching/ academic staff having served SCE for at least 2 years and with at least a one-year renewable contract at the time the award is granted. Those staff who have served SCE for at least 2 years but are incidentally under appointment review in the year of the award are also eligible. The award recipients must also be full-time teaching staff of the School by the time the award presentation ceremony is held.

b) Award

A maximum of one award may be selected each year on a competitive basis for each of the two categories, i.e. Individual, and Group. Award recipients will be recognised at the award presentation ceremony.

Category	Award
Individual	 Certificate of Research Excellence; Cash Award at the amount of \$2,000; and The recipient will be granted with teaching relief of one course in an academic year, which could be the award year or the year following that, if he/she does not already have teaching relief at the time of taking the teaching relief.
Group	 Certificate of Research Excellence for each team member; Cash Award at the amount of \$4,000 for the whole team (to be shared equally among team members); and The team leader of group award recipient will be granted with teaching relief of one course in an academic year, which could be the award year or the year following that, if he/she does not already have teaching relief at the time of taking the teaching relief.



c) The Assessment Criteria to be used in judging the nominees

- *Quality and impact of the scholarly work* (e.g. Research publications, Conference presentations/papers)
- **Recognition in the field** as evidenced by invitations to be keynote speakers in international conferences, and/or member of the editorial board for refereed journal publications.
- Successful award of major external research grant or consistent and active engagement in consultancy projects.

d) Review and Selection Process

- 1. The "Dean's Award (Research Excellence) Selection Panel" (DASP), with Dean (or his designate) as Chairman, 2 Academic staff from HKBU Proper at the rank of Associate Professor or above and RMC Chairperson as members, will be formed for the review of the applications.
- 2. The DASP serves to consider and assess the applications according to the approved selection criteria, and look for the behavioural traits, evidence-based materials, and/or achievements of nominees in the past <u>five</u> years within SCE.
- 3. Nominees may be required to attend an interview to provide further details.
- 4. After a thorough review process, the DASP will make recommendation on the recipients of the Award for the consideration and approval by the RMC. The Panel reserves the right to have the award of a category unfilled in any particular year if the quality of the application is considered insufficiently meritorious.
- 5. Following the recommendation of the Panel, the decision of RMC is final and cannot be the subject of appeal.

e) Application procedure

- 1. The RMC Secretariat calls for application once a year. Eligible full-time teaching/ academic staff can apply in the form of :
 - a) Self-nomination as supported by Division Head/Director concerned, or
 - **b**) Nomination by the direct Supervisor/Division Head/Director concerned.
- 2. The completed Application form (*Annex 1*) should be signed by relevant parties where appropriate.
- 3. Division Head/Director will make recommendation and submit the form to the RMC Secretariat before the application deadline.
- 4. Upon receipt of an application, the RMC Secretariat will send an interim reply to the Division Head/Director and nominee(s) to acknowledge receipt of the application.
- 5. The application deadline for AY 2021/22 is 5pm, 27 September, 2021 (Monday).
